The incumbent in this position is expected to assist the College in achieving its mission, which is to provide an educational structure and an integrated learning environment for individuals to become midwives of technical expertise, professional excellence, and personal greatness—namely, Midwives of ExcellenceTM

Position Overview

Midwives College of Utah (MCU) places primary emphasis on excellence in didactic instruction in an on-line learning environment. The Academic Dean is responsible for the development and management of curriculum that will help students to acquire, critically analyze, and apply foundational knowledge, skills, and behaviors necessary to achieve an undergraduate degree in midwifery science.

Duties and Responsibilities

- Serve as a member of the Senior Leadership Team, guiding institutional strategic directions and collaborating on diversity, anti-oppression, anti-racism and social justice efforts at the College
- Serve as a member of the Grievance Committee, Student Conduct Review Committees and ad hoc committees as necessary
- Coordinate with Faculty Director to determine professional development training to support faculty in curriculum writing and teaching in a distance-education platform
- Coordinate with Graduate Dean on matters related to institutional and student oversight that impact both the graduate and undergraduate programs
- Coordinate with the Clinical Director to ensure the curriculum links theory with practice
- Supervise integration of courses into Canvas (the learning management system), including syllabi and exams
- Oversee exam process for all academic undergraduate course work, including challenge exam
- Ensure ongoing compliance, through the provision of rationales and documentation, of Midwifery Education Accreditation Council (MEAC) standards and benchmarks relative to the Academic Department
- Co-manage MCU's assessment and evaluation processes for the undergraduate program, including student achievement of program objectives
- Review, evaluate, and develop improvements to program policies, procedures, and student services
- Develop and track the Academic Department budget
- Respond to curriculum inquiries or complaints from faculty, students, and regulatory agencies
- Advise and assist assessment of transfer credit and portfolio evaluations

Minimum Qualifications

- A bachelor's degree from an accredited college or university in midwifery, higher education, leadership, health sciences, and or/related fields
- Demonstrable excellence in teaching and practical experience in midwifery education or a related higher education discipline
- Significant administrative or leadership experience
- Familiarity in direct-entry midwifery education and training routes, professional issues, and/or learning competencies
- Proficiency in Microsoft office suite (or equivalent) and Adobe
- Proficiency in digital communication and project management technologies, such as GoToTraining, Dropbox, Smartsheet, JoinMe, etc.

• Possess exceptional written, oral, and interpersonal communication skills

Preferred Qualifications

- A master's degree from an accredited college or university in midwifery, higher education, leadership, health sciences, and/or related fields
- At least one-year experience in higher education administration, including understanding of the function and role of Student Information Systems (SIS)
- Familiarity with accreditation processes in the United States
- Experience as a midwife with expertise in normal, physiologic birth in home and/or freestanding birth center settings (certified professional midwife, certified nurse-midwife, other recognized form of midwifery credentialing, traditional midwife, or community midwife)
- Experience with Canvas or an equivalent Learning Management System (LMS)
- Experience working in a distance or tele-commuting work environment
- Training/education or experience in distance education pedagogy and online course development
